WL043 – In response to VVL's request to address erosion into lake from vacant lot, install Bio Sock system at lake edge. Bio Sock to be installed in a 3" depression along lake frontage, using stakes, and Bio Sock will wrap up the sides of the lot five feet along the walls.

<u>Motion:</u> To approve on the condition the system is functioning to prevent erosion. Motion by R. Johnson, seconded by B. Kalkman Motion passed four votes in favor, one opposed.
